

THE 2026 ERTL ST. PATRICK'S DAY GIVEAWAY

OFFICIAL RULES

NO PURCHASE REQUIRED TO ENTER OR WIN

1. **ELIGIBILITY:** The 2026 ERTL St. Patrick's Day Giveaway (the "Sweepstakes") is open only to legal U.S. residents of the fifty (50) United States and the District of Columbia who are eighteen (18) years of age or older at the time of entry. Employees of TOMY International, Inc. or other companies associated with the promotion of the Sweepstakes, as well as the immediate family (spouse, parents, siblings, and children) and household members of each such employee are not eligible. The Sweepstakes is subject to federal, state, and local laws and regulations and is void in Puerto Rico and where prohibited by law.

Limit one (1) entry per person. Additional entries will be disregarded. Your odds of winning will be based on the number of eligible entries you submit and the total number of eligible entries received. Any entries attempted through the use of agencies or robotic, repetitive, automatic, programmed, or similar methods will also be void.
7. **DRAWING:** On or about March 23, 2026, the Sponsor will select the name of the potential winners in a random drawing of all entries received. The odds of being selected depend on the number of eligible entries received. The Sponsor will attempt to notify the potential winners within seven (7) days of the drawing. In the event that the potential winners are unable to be contacted within seven (7) days of the drawing, a subsequent random drawing of all entries received will be conducted.

8. **REQUIREMENTS OF POTENTIAL WINNERS:** Except where prohibited, the potential winners may be required to complete and return an affidavit of eligibility and liability/publicity release (the “Affidavit/Release”) within seven (7) days of being notified.
